REGARDING NON-REEMPLOYMENT OF CERTIFICATED EMPLOYEES

WHEREAS, on March 6, 2008, the Board of Education of the Lompoc Unified School District adopted Resolution No. 62 to decrease certificated staff due to a reduction in particular kinds of services; and

WHEREAS, notice of non-reemployment was given to the affected employees on or before March 15, 2008; and

WHEREAS, each affected employee expressly waived his or her right to a hearing in this matter; and

WHEREAS, Education Code section 44949 provides, "If an employee fails to request a hearing on or before the date specified, his or her failure to do so shall constitute his or her waiver of his or her right to a hearing"; and

WHEREAS, it was determined that 38.5 full-time equivalent services of the District be reduced and an equivalent number of certificated staff shall be laid off for the ensuing 2008-2009 school year.

NOW THEREFORE, BE IT RESOLVED, consistent with Resolution 62, that the employees listed below shall be non-reemployed, effective for the 2008-2009 school year. This status shall be effective on June 30, 2008:
